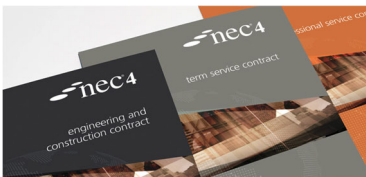
At the outset of an NEC Project it is essential that both the Employer and the Contractor fully understand the most efficient and effective way to deliver the project. The Contracts Group NEC experts can assist our Clients to draw up an Implementation Strategy and Contract Procurement Strategy to ensure that their goals are fully understood and that risk is placed with the party best placed to manage it.

Key elements of an Implementation Strategy may include:

- Advising upon the Organisational Structure and level of resource (including the identification of agents and external specialists who will supplement the team) that will be required to successfully deliver the project objectives, particularly in relation to the use of the NEC form of Contract;
- Advising upon the mechanism for project communication, including the use of online platforms and training courses;
- Advising upon project governance and mechanisms to ensure that there is a robust procedure in place for managing project change and for quick, but considered, decision making, to ensure that the timeframes incorporated into the NEC form of Contract are met;
- Development of a detailed risk register to identify key project risks and assign the best party able to manage and mitigate those risks;



Key elements and considerations in a Contract Procurement Strategy will include:

- Identifying the best Pricing Option to meet the Clients requirement and

their scope of Works. Also identifying the most appropriate secondary options and Z Clauses;

- Review of the possibility for advanced packages or early Contractor involvement to ensure that the early works programme is met;
- The possibility for two stage tendering for major works packages to ensure alignment of project objectives, contract requirements and to ensure the project Works Information and Accepted Programme are fully understood by all parties;
- Defining the gain / pain mechanism for NEC Target Cost Contracts, should they be used;
- Allocating risk within each works package



to the party best placed to manage and mitigate that risk;

- Identifying key areas where problems may arise in the use of the NEC form of Contract which may include ensuring there is appropriate delegation of authority to make decisions in a timely manner, ensuring there is sufficient specialist resource to manage the Accepted Programme and ensuring there is sufficient resource to meet the additional contract administration requirements that is quite often required for NEC contracts;

Confirmation through detailed procedures as to how each key element of the NEC Contract should be managed on the project. This will include the procedures for managing Early Warnings, Risk Reduction Meetings and Compensation Event Notification and Assessment.
